Update on the 2018 ASAUK Conference

Preparations for the 2018 Conference of the African Studies Association of the UK, to be held on 11-13 September at the University of Birmingham, are progressing. I am very grateful to the support of Elisa Tuijnder, our fantastic conference organizer this year, the University of Birmingham, the ASAUK Council, the Royal African Society, and other colleagues for supporting conference organization and planning.

After receiving several requests for an extension of the deadline for submissions, the abstract submission deadline has been extended to 30 March 2018. With over 1,000 registrations on the organizing system, 50 streams covering a wide range of topics, many stand-alone panels, roundtables, film presentations, and book launches, the conference is beginning to look very exciting. In addition to the traditional conference dinner, where the Association's prizes will be awarded, the conference programme also includes an informal get-together on the first night over a barbeque.

The keynote address, given by Kenyan and South African public intellectual Professor Grace Musila from Stellenbosch University, is entitled "MAKHUMALO'S SPAZA SHOP | LENA MOI'S DANCE" and will set the life stories of South Africa's Gertrude Sizakele 'MaKhumalo' Zuma and Kenya's Helena 'Lena' Tungo Moi in conversation.

In addition to bursaries awarded by Stream organisers, the conference has so far raised the funds for 30 bursaries for African scholars, funded by the Guggenheim Foundation, the ASAUK, and the College of Arts and Law and the Department of African Studies and Anthropology at the University of Birmingham. This year we have created the additional possibility for all conference participants to make a small donation towards further bursaries when paying for the conference. The conference organisers would like to thank all those colleagues who have contributed to our bursary funds upon registration. Early bird rates will be maintained until 1st June 2018 in order to encourage everyone to pay early so that we can offer additional bursaries for African scholars later in the year.

We are collaborating closely with the Royal African Society and the University of Birmingham to ensure that we can provide strong support to all colleagues in need of a visa. Please note that all visa support requests will have to be submitted by 1 June 2018 to the conference organisers to that we ensure a high number of African and other international participants.

The conference organizing committee and I are greatly looking forward to welcoming everyone to an amazing conference at the University of Birmingham in September!

ASAUK Statement on Strike Action

The African Studies Association UK (ASAUK) expresses full support to its members undertaking industrial action against proposed changes to the Universities Superannuation Scheme (USS).

We are extremely concerned about the deleterious effects that the proposed pension cuts would have on attracting and retaining the international scholars upon which African Studies relies. This will aggravate the difficulties we face because of an increasingly hostile visa regime and fallout from the decision to exit the European Union. The proposed changes would have serious consequences for equality. They will have a disproportionate adverse effect on women, on early career colleagues and on Black and Minority Ethnic academics, all of whom we represent.

We believe that this will have a direct bearing on our intellectual mission of supporting world-leading Africa-related research. We call upon Universities UK to withdraw its proposals for changes to USS and to prioritize securing a fair pension plan that values the teaching, research, and professional services staff upon whom universities rely.

'Congolese Studies: Past, Present, Future', Congo Research Network Conference 2018, St Antony's College, Oxford, 26-27 April 2018. The conference aims to bring together junior and senior scholars across the humanities and social sciences, sharing a common interest in the DRC. It specifically aims to provide space for interdisciplinary and comparative analyses and reflections, within and beyond Congolese Studies. Congo's geographic centrality, the sustained demand for its resources on global markets, the dynamism of the country's popular culture and its cross-border relations offer opportunities for collective thinking on the DRC's place in broader dynamics of historical, social, political and economic change in Africa and beyond.

The conference will provide an opportunity for reflecting on more than half a century of research on Congolese cultures, history and societies. The organisers are delighted that Professor Bogumil Jewsiewicki will give a keynote address on the history of Congolese studies: a roundtable of prominent scholars of Congo from different generations will reflect on the contribution of the 'independence generation' of Congolese studies for the study of Central Africa today and in the future.
